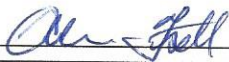

need through a network of volunteers. Childspring International also provides aid to
orphanages, hospitals malnutrition centers and other organizations benefiting
children. Childspring International works to heal children by education and by
training host nation medical professionals to enhance their medical proficiency.
Medical services are provided in the US and overseas. Childspring International
receives assistance and support from medical professionals, businesses, foundations,
churches and individuals. During 2016, Childspring treated 407 children from 10
developing countries. 8 of those children were treated in the United States. The
other 399 children were treated in 5 countries outside the United States and in those
cases, generally, the child was treated in the country in which they reside.
